



## REDDING PITS — WINFOLD

*History:* The mining of iron ore in the Winford area (NGR ST 5342.6370) has been going on for hundreds of years. No one knows exactly when it began, but historians say that the blacksmiths of Bristol were using iron from the hills near the village 600 years ago. The Winford Iron Ore Company (which no longer exists) was formed in 1878 when a number of small operators were drawn into one enterprise. As time went on the use of the Winford iron for smelting slowly came to an end but was replaced by an even more important form of production, red oxide of iron, or as it is sometimes called, red ochre. The Winford Iron Ore Company then changed its name to the Winford Red Ltd.

The material was mined in open cast system until the quarry's closure, but up to the 1920's the Winford miners drove their tunnels along the seams of the ore. The old workings were reported to be an "absolute rabbit-warren" with the further reaches unsafe for further investigation. What happened to the deep red ore after it had been mined, ground to a fine powder and put into barrels? It went, literally, all over the world. It was sent to the West Indies and the Philippines where it was used to colour cement and concrete - to cut down the glare from the walls of new buildings. An African tribe in the Transkei, the "Red Kaffiro" used the red oxide by beating it into the blankets they used as garments. The dressing was soon transferred from blanket to wearer giving him or her a red colour.

Before mechanisation came to mining, more than 100 men worked for the Iron Ore Company and the ore was taken to Bristol for shipment in a "road train" of three big wagons drawn by the company's own traction engine. It is interesting to note that the red material known in the country as "ruddle" has been used "time out of mind" for marking sheep. Today the quarry is closed, its main usage appears to be by trials bikers. The open cast area is surprisingly large and the gallery whose grid reference is given above lies near the foot of the west face. Access to the area is best approached from the track which runs along the southern boundary of the quarry, but parking space is very restricted and turning space even more so.

*Brief description:* A low, wide entrance goes downslope to a T-junction. Passage dimensions are large: 5m x 3m. To the right closes down while turning left leads to a slope. Following this around to the right and scrambling over the large, and some loose, boulders drops down into slightly smaller walking-size passage. There are numerous side niches and an optional tight squeeze on the right. The way on is under an obvious concentration of shoring which emerges at the foot of a mud scree slope. Climbing up and to the right an unsupported mass of conglomerate asks not to be touched and a "sizeable chamber" is a good description for this location. Continuing downslope a choice of routes all interconnect into a large meandering passage. A low arch on the right gives upslope access to a final section of highly fragmented rock. The final crawl to the end is very unstable and best viewed from a distance. Back at the foot of the mud scree slope, turning left and scrambling downhill brings you to a small "hole" on the right. Dropping down through the hole leads to a short crawl opening out into a large chamber. There are several crawls leading off but all eventually close down. Climbing upslope and through a constriction enters a small chamber with a tube on the left. Sliding down this section eventually returns to the "hole", now on the left.

Although not surveyed there is a good 1000ft plus of passageway, the main problem is, there is still plenty of ochre about and it gets everywhere! My thanks to Vince for the location and Tony Jarrot and the North Somerset Mercury for the history. JB

## EXPEDITION NEWS

### SIMA GESM UPDATE

It would appear that my previous press release contained a couple of errors - namely that of the two sets of dates published, neither were correct! The actual (and final) dates for the expedition are 13th August to 28th August.

That slight hiccup out of the way, I am able to report that the expedition committee has been formed and consists of the following:

Regular meetings are now being held and it is quickly becoming apparent to all concerned, just what a major undertaking this expedition is. A great deal of equipment will be needed by all members of the team. One problem we have to face is that of organising a base camp at the cave entrance. Personal tents are no problem but we still lack suitable cooking / equipment tents. If anyone can help with the loan / hire (or the cheap purchase) of such tents could they please contact Andy Beare. Please remember that they will need to be light enough to carry the final mile from the road to the camp site.

Another problem is finance. We are approaching companies and organisations for sponsorship of any form be it equipment, food or money. If you think you can help in any way - perhaps you know a company who would like to get some free publicity - please contact Lesley Robbins.

Final numbers for the main caving team are limited to a maximum of twelve and a deposit (to be agreed) will be required to secure a place, although anyone else will be able to descend when the cave is rigged. An overall costing is being worked out at the moment and this will be published with further details in the next newsletter.

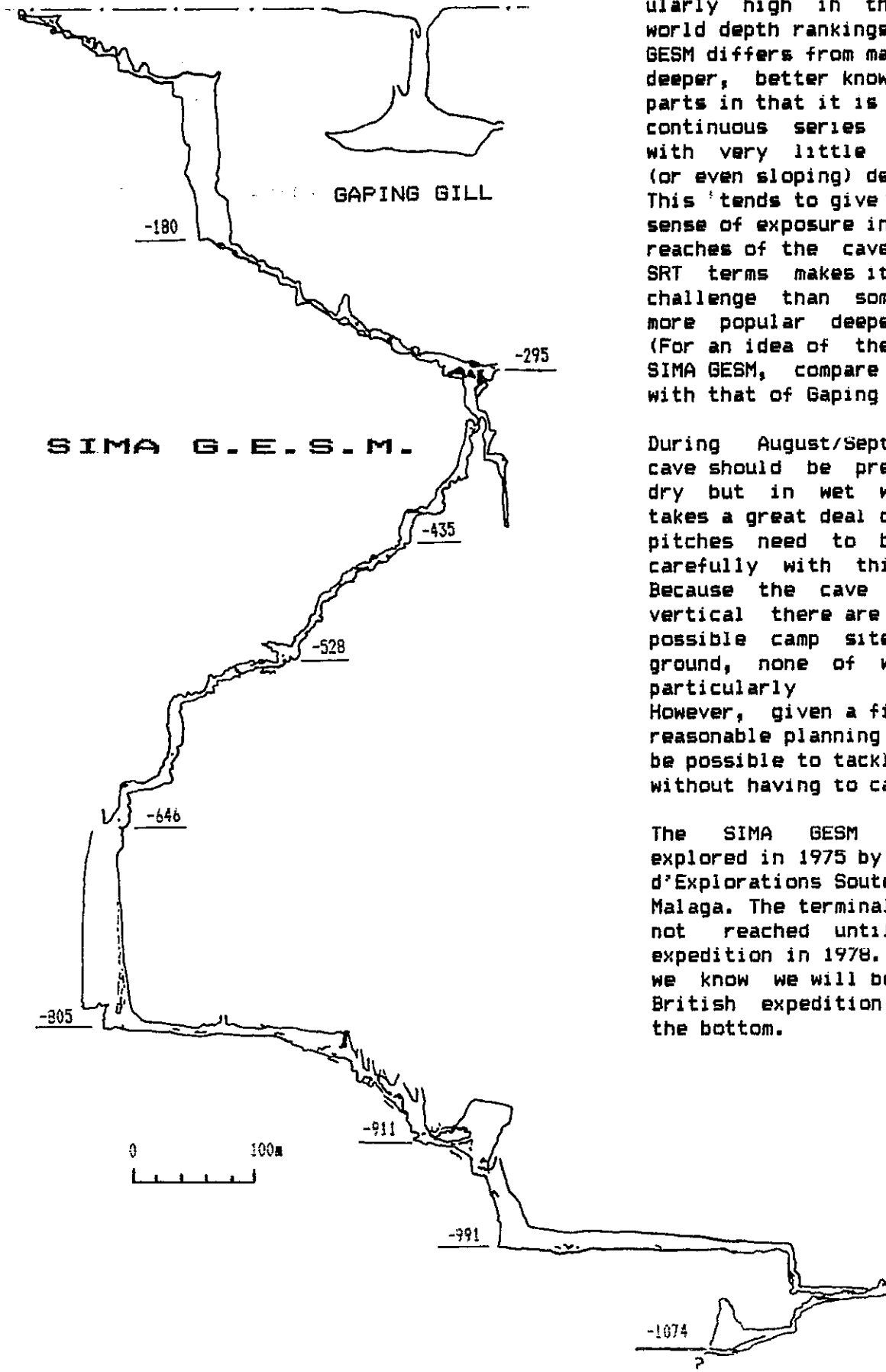
SIMA GROUPE D'EXPLORATIONS SOUTERRAINES DE MALAGA

The SIMA GESM is located at 1670m on the Sierra de Tolox above the town of Ronda in southern Spain. The cave is 1074m deep and contains 37 pitches, the longest of which is the 161m Paco de Torre. In all, a total of 1300m of rope is required to reach the

bottom. Although not particularly high in the list of world depth rankings, the SIMA GESM differs from many of its deeper, better known counterparts in that it is an almost continuous series of pitches with very little horizontal (or even sloping) development. This tends to give a terrific sense of exposure in the lower reaches of the cave, and in SRT terms makes it a greater challenge than some of the more popular deeper systems. (For an idea of the size of SIMA GESM, compare the survey with that of Gaping Gill).

During August/September the cave should be predominantly dry but in wet weather it takes a great deal of water so pitches need to be rigged carefully with this in mind. Because the cave is mostly vertical there are only three possible camp sites underground, none of which looks particularly inviting. However, given a fit team and reasonable planning it should be possible to tackle the cave without having to camp.

The SIMA GESM was first explored in 1975 by the Groupe d'Explorations Souterraines de Malaga. The terminal sump was not reached until a later expedition in 1978. As far as we know we will be the first British expedition to reach the bottom.



## MENDIP CAVING GROUP CONSTITUTION AND RULES

### PART 1: ADMINISTRATION

1. NAME. The full name of the Group is the MENDIP CAVING GROUP.
2. OBJECT. THE OBJECT OF THE Group is, for the benefit of the public, the furtherance of all aspects of the scientific study and conservation of caves.
3. MEMBERSHIP. Membership shall be open to anyone over the age of 16 years with an interest in the objects of the Group.  
There are four classes of membership as follows:
  - (a) FULL MEMBERS, i.e. people who have been probationary members for at least six months, who have completed a training trip (as defined by the committee) and who have been approved for full membership by a majority vote at a committee meeting.
  - (b) PROBATIONARY MEMBERS, i.e. people who have been proposed by two full members, who have attended at least one Group meet where committee members were present, who have been advertised in the newsletter or notice board for at least one month and who have been accepted as probationary members by a majority vote at a committee meeting.
  - (c) ASSOCIATE MEMBERS, i.e. either (i) former full members who are unable to play a full part in Group activities, but who wish to continue their association with the Group. Their change of membership requires the approval of a majority vote at a committee meeting.  
Or (ii) full or probationary members who have gone abroad for a period of at least six months. They shall have the status of associate members until their return to the United Kingdom.  
Or (iii) persons who wish to become members of the Group, but who are unable to take part in the regular caving activities and who have been approved by a majority vote at a committee meeting.
  - (d) HONORARY MEMBERS, i.e. people who have given exceptional service to the Group. Election to this class of membership requires a unanimous vote of the committee.

Note: Persons aged under 16 years may be sponsored by a member and attend meetings as their guests.
4. PRIVILEGES OF MEMBERSHIP. Use of the Group's cottage at reduced rates, use of Group equipment and the library, free publications and advice of meetings and activities. Full members may stand for election to the committee and vote at general meetings.  
  
Associate members have similar privileges except that they have no vote at general meetings, and not more than one at a time may hold office on the committee.  
  
Probationary members have the same privileges as associate members except that they may not stand for election to the committee.
5. EXPULSION FROM MEMBERSHIP. Membership may be terminated by the decision of two-thirds of the committee (all being present). The member shall be notified of the intention of expulsion, and shall be given reasonable opportunity of attending the meeting and presenting a case. A full or associate member may appeal against the committee's decision to a general meeting called for this purpose by the secretary.

6. **SUBSCRIPTIONS** are payable on January 1st each year. Members failing to pay by January 31st may have their membership terminated. Members joining after June 30th in any year shall pay reduced subscriptions at pro-rata rates.  
The amount of subscription shall be determined at a General Meeting and notified to members in time to take effect from the next due date of subscription.
7. **COMMITTEE.** The Group's business shall be regulated by a committee of eight members. They will normally be elected at the annual general meeting to serve for a period of twelve months. If a post falls vacant during the year, a substitute officer may be co-opted for the remaining period.
- The honorary officers shall be: Secretary, Treasurer, Meet Secretary, Cottage Warden, Tacklemaster, Editor, Recorder and Ordinary Committee Member.
8. **COMMITTEE MEETINGS.** Any officer may call a committee meeting. Four officers shall constitute a quorum. The decision of the committee shall be binding on all members unless varied by a majority vote at a general meeting.
9. **GENERAL MEETINGS.**
- (a) An Annual General Meeting shall be held in the Spring. At other times an Extraordinary General Meeting may be requested by either the secretary, or three committee or five full members.
  - (b) Seven days notice in writing of a general meeting shall be given to all members by the secretary.
  - (c) The chairman of each meeting will be appointed by the committee.
  - (d) Nominations for office and proposals to change the Constitution and Rules shall reach the secretary at least 21 days before the meeting.
  - (e) Votes at general meetings shall be counted by two tellers appointed at the meeting. Voting for officers shall be by secret ballot and the number of votes cast shall not be revealed.
  - (f) The committee may grant a postal vote to any member who applies in good time to the secretary.
10. **FINANCE.**
- (a) The Group's funds shall be placed in such account, or accounts, with banks or be otherwise invested as the committee shall direct.
  - (b) The treasurer shall keep proper accounts and receipts of all transactions.
  - (c) The signatures of two members, as nominated by the committee, shall be required on all cheques and notices of withdrawal.
  - (d) Two auditors shall be elected at the Annual General Meeting to serve for a period of one year. They shall audit the books up to the end of each calendar year, and may conduct audits at such times as they may deem necessary and report thereon to the committee.
  - (e) The signatories may require the authority of the committee before signing cheques etc. for sums in excess of £200.
11. **THE CONSTITUTION AND RULES** of the Group may be changed only if approved by at least four-fifths of the members voting at a general meeting. No amendment may be made which will cause the Group to cease to be a charity at law.
12. **NEITHER** the Mendip Caving Group, nor the committee of the Group, nor any member, can accept responsibility for any loss, injury or death arising from a Group activity, howsoever caused. In particular, members and guests stay at the cottage and camp and cave with the Group entirely at their own risk. Nor is responsibility accepted for the loss, or any damage to personal property. Members of the Group and guests are deemed to know of, and accept without qualification, this rule.

13. THE COMMITTEE shall have full powers to deal with any matter that might arise that is not otherwise provided for in the Constitution and Rules.
14. TRUSTEES. There shall be four trustees of the Group. The first trustees shall be appointed by the committee, and the property of the Group (other than cash which shall be under the control of the treasurer) shall be vested in them to be dealt with as the committee shall direct by resolution (of which an entry in the Minutes Book shall be conclusive evidence). The trustees shall be indemnified against risk and expense out of the Group property. The trustees shall hold office until death or resignation or until removed from office by a resolution of a majority of a quorum of the committee present and voting at any meeting. Where necessary, the committee shall, by a like resolution, nominate the person or persons to be appointed the new trustees and, for effecting such nominations, the secretary is hereby nominated as the person to appoint the new or additional trustees of the Group within the meaning of Section 36 of the Trustee Act 1925. He shall, by deed, duly appoint the person or persons so nominated by the committee as the new or additional trustee or trustees of the Group. The provisions of the Trustee Act 1925 shall apply to any such appointment. Any statement of fact in any such deed of appointment shall, in favour of a person dealing bona fide and for value with the Group or the committee, be conclusive evidence of the facts so stated.
15. DISSOLUTION OF THE GROUP. In the event of the dissolution of the Group, and after satisfaction of all due debts and liabilities, any remaining assets may not be distributed amongst the members but will pass to a body with similar objects established for exclusively charitable purposes or to some other charitable body.
16. THE GROUP recommends that all members read and act in accordance with the National Caving Code as published by the National Caving Association, enclosed with this Constitution and Rules.

## BREAKTHROUGH IN UPPER FLOOD

If you subscribe to Descent, you will know by now that we have made yet another breakthrough in Upper Flood. As Descent are threatening to print the full details before we do, here is a brief description of the new passage. MCG Newsletter 174 described the dig as it was on 6th June '87 when Alan Dougherty and Vince Simmonds removed a large boulder in the mud crawl beyond Hannah's Grotto and were rewarded by a good draught.

Work continued, and soon we encountered more liquid mud filling the constricted passage almost to the roof. This was bravely passed by Vince who found that after 2m the roof lifted at a T-junction. A tight squeeze to the right entered an ascending rift passage in Black Shale leading to a small chamber and various small passages and avens.

Back at the T-junction, turning left, the roof of the mud filled passage lowered so that it was impossible to stand. Swimming/crawling through the canal of liquid mud was possible for about 15m until the passage became too tight. Several people tried to push the squeeze, but it was finally removed chemically. A stream could now be heard ahead. Passing the squeeze, we entered a deep pool of ...liquid mud! The loud stream was only an acoustic effect as a small stream (possibly the Sunset Boulevard stream?) entered from the left. Ahead, a natural barrier holds back the deep mud of the pool and the canal. The stream flows over this only to disappear again at a boulder ruckle beneath a small chamber. Work continues, but the nature of the mud canal has not encouraged the diggers!
