

Golden Chamber: the story so far

"Only a slender stream of water trickles down the Blackmoor Valley, and before it has travelled far a series of swallets reduces its volume still further, until by the time it reaches the Priddy road it has completely disappeared." (Gough, 1967).

The Mendip Caving Group and the caves of the Blackmoor Valley have been intrinsically linked since the early 1950s. Of these, Upper Flood Swallet in particular has held a peculiar fascination for several generations of MCG cavers. I think I would describe this as a love-hate relationship, and for good reason. Despite the wonders of Midnight Chamber, much of the cave is pretty grim at the best of times - relentless crawling, flat out squeezes in cold water, chokes of suspect stability, and oodles of gritty, black, lead tailings thrown in for good measure. But there is something intriguing about the place that keeps dragging us back for more. Where does that streamway

Since 1987 the boulder choke at the back end of the Red Room has proved to be an extremely stubborn obstacle. Efforts have been made on and off since then to get under, over, around and through the choke but to no avail. The lower levels had always been rather disconcerting. On occasions you can hear the streamway ahead but the further you dig the keener the rocks are to rattle down and hamper your efforts. At the end of the old dig you can still see a

crow-bar trapped underneath the collapse at the face. The intimidating nature of the place, plus the fact that you get a thorough soaking in Puddle Lake just before the Red Room, has meant that, to be honest, in recent years the club had pretty much avoided another serious attempt to pass the choke.

However, a few of us could never quite give up although admittedly this was more in the form of long ramblings in The Eclipse, Castle of Comfort, Nordrach Cottage and other venerable armchair-caving venues. The long sought-after breakthrough came on the 29th August 2004 after a session of particularly sporting digging by Peat Bennett and I. But actually, the way on had been noted way back in 1988 and flagged up in the Upper Flood journal, Occasional Publication No.4:

"It may be recalled that a strong air current had been noted emanating from a hole in the boulder choke in Andrew's Grotto when it had first been entered. The writer [Malcolm Cotter] had made an attempt at digging there but had been put off by the way rocks had tumbled from above".

Just above the old dig face was what appeared to be a small, mud filled crack that headed over the dig. The right-hand wall was the fault and to the left and above appeared to be boulders. I had often sat shivering in the void in the choke below

whilst waiting for rocks and mud to be passed back and wondered about this crack. Strangely, once back in the pub, the crack always seemed to be remembered as a much more promising lead than it looked in reality. Something like ten years elapsed before I finally got around to actually doing something about it, after all other avenues had pretty much been exhausted. (Entries in italics are from the author's logbook; numerous non-digging trips and trips curtailed due to high water excluded).

06.10.01 "Still very low water. Temp 11°c so almost a pleasant stroll to the Red Room. Carried in three scaffolding bars that Lee had left at the Lavatory Trap. Started a new dig in a mud filled rift in the choke. Is it solid or is it boulders? The next trip will see." (Team: PB, TF)

This was a bit of an understatement though. We put a small cube of wood under a car-sized boulder for some psychological scaffolding, although I don't think either Peat or I were convinced of its life-saving properties. But ultimately, digging up into the crack did not prove as dangerous as Malcolm had predicted. We could see a void over the top, so theoretically by digging underneath the boulders for a few body lengths, we might pop out into the air space.

17.02.02 "Myself and Julie did some more work on the promising dig in the boulder choke in the Red Room. This looks like we could finally have found the way out of the terminal choke. "(Team TF, JH).

It was starting to look like we had a mud-filled tube that was at least solid on the right-hand side and the boulders up the left looked large enough to be staying put. Cottage theories were expounded that we may be digging up a choked inlet. It was starting to look like an awkward body-sized tube but at least the ceiling wasn't going to collapse.

02.03.02 "Milled around the cottage until Lee and Jacky turned up. Down a rather wet Upper Flood for a spot of digging in the Red Room. Continued to work on the new lead in the choke. We were just starting to head out when Ben arrived. I carried on digging with Ben whilst the other two headed out. It looks small but still worth pursuing." (Team JA, BC, TF, LH).

After this trip it became apparent that an extended dig in the choke was going to become a real hassle. We had filled up our alcove in the choke with mud, and without a quick breakthrough the spoil was going to have to be dragged back past Andrew's Grotto and all the way to the Red Room. No-one was that optimistic so it was a long time before we made another proper digging trip.

27.03.04 "Post AGM crawl to the pretties for myself and Louisa. The others carried on to the end to look at the dig. Water 9°c. Air 11°c." (PB, BC, TF, SG, LM).

06.06.04 "A digging trip in the muddy tube in the boulder choke. Very low water levels. So actually it wasn't that cold or wet in the crawl or even at the dig. We're now in about ten feet." (TF, MP)

This was actually a successful trip in that it confirmed that the tube was definitely formed in solid rock rather than an extension of the boulder choke. It seemed to be meandering off to the right but I was starting to think that we were following an inlet. But at least it was somewhere to dig which was better than nothing.

11.07.05 "Digging in the boulder choke. This muddy rift still looks worth pursuing. We left a load of spoil that needs tidying up on the next trip." (TF, LM).

We were now coming up against spoil removal issues. With just two of us the dig was becoming a two stage operation just to get spoil back to Andrew's Grotto. The dig though was looking good. We'd excavated a duck-under on the left hand side and we could see some air space only a metre or so ahead. However the dig on this side seemed to be trending back into the choke which wasn't exactly the plan.

29.08.05 "Thought we'd do a spot of digging in Upper Flood. Barely any streamway flowing. Carried on the choke and forced a way through the choke to enter a new chamber. This was well decorated with straws and a flowstone flow. To the left is a nice ledge covered in crystals. We've definitely passed the choke. The left hand wall is on the choke and it does draught from somewhere. At the far end is a

mud fill wall right up to the ceiling. Too knackered to remove the spoil so we headed back to the cottage to celebrate." (PB, TF).

Peat and I had been planning to go to the P.O.B. dig in Draenen but Duncan had bailed out on us. So thank you Duncan! For most of the afternoon we'd furtled around in the dig and probed the arch on the left as far as our arms could reach. Eventually I decided to squeeze underneath the arch and 'encourage' the roof down. I had soon buried myself up to my waist in spoil but the roof started to look reasonably solid. Peat was able to clear the spoil back to keep my legs free and so I carried on probing ahead. There seemed to be a way underneath a flowstone shelf, and much to our surprise a black space appeared up ahead. With encouragement from Peat who was still frantically trying to find somewhere to dump the spoil – eating it seemed to be the best option – I forced a way over a pile of mud and belly flopped into a small chamber.

This was extremely well decorated. The roof is covered in fine straws, typical of Upper Flood, and there is a fine flowstone cascade on the right hand side. The highlight of the chamber, and unique to the cave, is a small ledge that is completely covered with calcite crystals. On account of the 50th anniversary of the MCG and the pretties Peat came up with the idea of "Golden Chamber". The chamber is extremely vulnerable but we've taken several rolls of film and Malcolm has it on video so if there is any damage it's been recorded for posterity.



Since the breakthrough we've completed seven digging trips to Golden Chamber. Initially it wasn't that clear where the way on might be. The back wall is completely made up of mud fill with no airspace or discernable floor. But in the floor we could hear the streamway rumbling away somewhere below. Since then we have dug down in the floor in the far corner and the streamway seems closer than ever. The fill is a made up of large boulders and gritty mud somewhat reminiscent of the good old days in Pinetree. But digging is the easy part. Hauling out the

New regulations on the manufacture and storage of explosives

The Manufacture and Storage of Explosives Regulations 2005 (SI Number [2005/1082]) have been signed by Minister for Work, Jane Kennedy, and were laid before Parliament on 5 April. The new regulations will come into force on 26 April 2005.

spoil is a nightmare. You have to cautiously carry small skips up the slope of the chamber and drop them onto a tray. The tray is dragged along the breakthrough dig and then spoil dropped down into the choke. On subsequent trips we've been passing the spoil through the voids in the choke back to a temporary spoil heap in Andrew's Grotto. Finally we're hauling large skip loads back under the squeeze and into the Red Room where a new spoil dumping area has been created. Volunteers always welcome.

The team are extremely optimistic about the potential for another breakthrough. We've taken a bearing along the passage and its trending towards the end of Waterwheel. However the considered consensus is that we expect the cave to take another sharp left before too long. There has long been a theory of another old swallet lying somewhere in the valley between Black Shale Rift and Blackmoor Swallet, which suggests that we may meet up with another small streamway coming in from the right. But enough of the armchair hypothesising, lets get on with the digging. And it is fingers crossed though because knowing Upper Flood it could be another ten years before we get any where. Here's hoping...

After the last year's well-attended 50th AGM, the number of members at this years was back to around 30-or-so; mostly the "usual suspects", with a few new faces. The meeting was chaired by Jonathan Roberts.

The minutes of the AGM held 9th April '04 were agreed with only minor changes. Martin Rowe wanted to point out that he only administers the MCG Yahoo Group and does not control it. The minutes of the EGM held 9th October '04 were also agreed.

The question of whether Gift Aid can be reclaimed on annual subs (currently £48 for full caving members) was discussed. Martin thought that subs and insurance should be separated and collected as two payments with Gift Aid reclaimed on the basic subs of £30 and insurance treated as a "personal benefit". Malcolm Cotter would like it looked into further.

Bob Templeman offered to to take novice groups underground but asked if novices/non-members were covered by the Group's BCA insurance. It was pointed out that they could cave with MCG as guests but were not insured.

Lee Hawkswell and Jackie Ankerman stepped down as Secretary and Treasurer. There was a round of applause for their busy year in the posts. They had done excellent jobs, especially with, for example, BCA insurance and the Group's 50th Anniversary.

Roy Kempston asked if we were subsidising the phone/phone calls. We are not subsidising phone calls, but the line rental is paid by the group as the phone was installed for emergencies like cave rescue. The cost of calls from the phone is covered by the charges. Roy thought that line rental should be shown separately in the accounts

It was thought that Lee's collection system for cottage fees is much better. The accounts are thorough and diligent and earned Jackie a round of applause.

The Cottage Warden, Doug Harris, said that major cottage work will be needed

this year due to its age. There is lots of decay, especially woodwork. The drains have now been sorted – a major task tackled by Doug, Malcolm and Mick Norton. Now the beech trees have gone you can see more of the rot, and the cottage will now be more exposed to the weather. We don't plan to replace the trees but may plant a hedge along the front of the property, either of beech or mixed. Fascias, lounge floor, drainage in the car-park are jobs still to be done. Doug is pricing up these jobs and will arrange a couple of work weekends. There was talk of a partition in the Foreman's Lounge to separate the sexes in scout groups etc.. There are more of these types of groups staying at the cottage. There was also talk of partitioning the showers to allow individual showers. It was agreed that it would be too expensive and the changing room would then need partitioning too. Apparently, plans were drawn up years ago so we could dig them out if it really becomes an issue. It wasn't felt that it would increase guest or membership numbers.

This year saw two other committee members stand down. Richard Carey (Caving Secretary) has left the group and Dave Tooke (Tackle Master) is working in the Sudan. Lee said in Dave Tooke's absence that the lifeline had been updated and that ladder is well stocked. Julie Hesketh asked if we are going to replace the SRT rope and was told that we will replace it bit by bit as agreed at the EGM.

Tim Francis, the Recorder / Librarian, said that due to work commitments he was concentrating on the Recording part of his post and keeping up with the committee minutes. Between 50 and 55 newsletters go to other clubs on exchange. The backlog has been cleared and it is now up to date.

The Social Secretary, Linda Milne, reported on the social events of the MCG 50th Anniversary: The Journal is on the way which Yvonne Rowe and Malcolm Cotter have done work towards. £670 was raised from the raffle and the auction. Suggestions for its use include a scaffold tower for caver training, but it would need inspecting and testing annually. We need to check on the cost of testing as it could be expensive? A scaffold tower would be good for beginners who have never tried rope or ladder before. Jonathan said it fits in with the aims of the Group. John Crowsley brings groups to the cottage who would use it and we need to encourage new and younger members.

A major project this year has been the removal of the diseased beech trees. The usable wood has been planked and is being seasoned. It will be sold to cover some of the cost of felling. Other bits can be used to make tables etc. The planks could make a table for the cottage – we have needed a new one for years. The planks are no more than 2 feet wide and 1 ½ inches thick. It was suggested that they need to be at least 2 inches thick for a refectory table.

Several posts for the new committee had attracted no nominations. After some arm-twisting, the committee emerged as follows:

Malcolm Cotter agreed to continue as Gift Aid administrator. He was applauded for his work. Keith Knight continues as Rescue Warden and Lee Hawkswell fills the vacancy for Access and Conservation officer. The group's new Examiners are Fiona Kempston and Anne Pittman. Until we can co-opt a Secretary, Malcolm will liaise with the Charity Commissioners

We need ideas for the Group's Hidden Earth '05. Louisa Minahan and Martin Rowe are to co-ordinate and have some ideas already.

Tim Francis proposed that we re-instate the London pub meet to help invoke interest in the Group – a point of contact. Numbers have dropped since pub meets

Logbook Extracts, February - April 2005

Week commencing 14.02.05 – Doug Harris felled two of the beech trees outside the cottage.

19.02.2002 Upper Flood (Lee Hawkswell & Jacky Ankerman). Stream in good spate. 10½°. Lavatory Trap quite low, but canal quite high! No thanks [JA]

25.02.2005 Riwaka resurgence, New Zealand (TimF, LouisaM) Whilst we were in New Zealand we met up with a few of the local cavers from the Nelson Caving Club plus picked up a copy of New Zealand Caving from Moira Lipyeat (the author) of the Marlborough caving Club. Popped into the Nelson Caving Club hut which is up on Tanaka Hill near Harwood Hole. Joel and Lump (Martin Graves) are out there on a two week expedition diving in Riwaka Resurgence and climbing avens beyond Sump 3.

We went in Riwaka for a tourist jolly as there's now a dug second entrance that bypasses the entrance sumps. Pretty, wriggly sort of stuff pops out in a huge chamber. The route further in is a bit tricky to find but Joel had left us with a little hand drawn map. A huge boulder pile hides the route to a fantastic stomping passage which apparently floods horrendously in wet weather. A six hour trip for us — it shouldn't take that long though if you know where you're going. [TF]

27.02.2002 GB Ladder Dig (LeeH, Doug Harris, Richard Perry). General tourist trip into Gorge, over Bridge, down White Passage, up into Ladder Dig. Back out

via Waterfall. Richard (new member) enjoyed himself. [DH]

05.03.2005 Swildon's (Geoff Beale, Mick Norton, + Bracknell & DCC). I went as far as the 20 ft ladder pitch to test out my elbow which had an injury several months ago. It passed the test! Water very cold but not much of it. [GB]

19.13.2005 Upper Flood (Louisa Minahan, Tim Francis). Air 10.5°C, water 10°C. Lovely sunny day but caving as usual. Heaved out all the spoil left in the choke on 5th Feb. Andrew's grotto is now full up so on the next trip we'll have to pull back to the Red Room. We then went into Golden Chamber and rigged up a scaffolding frame to protect the floor. This needs finishing plus the bolts are only finger tight. Please take in a spanner and tighten.

Easter 2005

25-26.03.2005 Sewer investigation and repair (DougH, MickN, Malcolm Cotter) Over the work weekend (Feb 5/6th) a blockage had been located at the cess pit end of the sewer pipe and an inspection hole was needed. Doug excavated the site half way through the month and found that the bend had fractured and the pipe had subsided about 3". On Good Friday the weather was fine, a trench was dug to expose the entire pipe length and a spare bend section was fitted — I don't want this report to put too much emphasis on the nature of the job, but it is someone else's turn if it happens again!

We realised that an inspection pit was desirable at the pipe bend but it was not possible to obtain a suitable half pipe bend so we decided to leave the linkage as before but put an inspection hole above. At the cottage end the main electricity cable was encountered. Doug and Mick prepared footings for inspection holes at each end of the pipework while Malcolm started to infill the trench. *[MOC]*

27.03.2005 OFD Columns Open Day (Martin Peck, LeeH, JackyA, LouisaM, TimF). Tour of the fossil stuff via the Labyrinth to the Columns. We avoided the puddle on the way back. Did a spot of touristing down Salubrious, The Judge *etc.* Supper back at the Westminster c/o Jacky *[TF]*

28.03.2005 Upper Flood (TimF, MalcolmC, DougH, MickN). Down to the Red Room. Malcolm and Mick moved rocks and spoil from the crawl down to Andrew's Grotto while Tim and Doug removed the stocked up soil from Andrew's Grotto to the bottom side of the squeeze in the crawl. Then we went into Golden Chamber, Tim and Doug assembled scaffolding at the bottom of the chamber. A streamway could be heard from the dig site. *[DH]*

Working at Height regulations

Representatives of the outdoor adventure sector have welcomed a decision in principle by Minister of State at the Department for Work and Pensions, Jane Kennedy to allow for the development of sector specific Temporary Working at Heights Directive regulations in relation to specified adventure activities such as climbing and caving.

The sector and MPs had lobbied the Minister following lengthy negotiations with the Health and Safety Executive, on the grounds that the Directive was not aimed at sporting activities, and that imposing it in its entirety could have severe and damaging effects on safety and businesses.

Alistair Burt MP for North East Bedfordshire accompanied John Cousins and Doug Jones of Mountain Leader Training UK, Tom Redfern of the British Caving Association and Brian Lamb of the Institute of Outdoor Learning to a meeting with the Minister and Health and Safety Commission Chairman Bill Callaghan on March 8th.

Alistair Burt MP said "We are very pleased with the outcome. The sector always recognised the point of the Directive in relation to those whose work temporarily involved working above ground, as in scaffolding or construction, but felt very strongly that it was never intended for sport. This view is held throughout the EU, and was confirmed in a legal opinion prepared for the Minister last November, which offered the opportunity that we had been seeking of allowing National Governing Bodies in climbing and caving to remain the key guardians of safety, a responsibility they have exercised superbly over the years. This decision finally lays to rest the threat of inappropriate safety provisions"

John Cousins, Executive Director of Mountain Leader Training UK said "we set out to ensure that adventure activity providers could continue their activities unhindered and believe that the proposal to except us from specific elements of the Regulations is an excellent outcome. We are grateful to everyone who has made their views known and for the support of the media and politicians, especially Alistair Burt and Jane Kennedy. We can return to the business of developing good practice and enjoying our sports."

Box Mines

English Nature are to install gates on all entrances to Box Mine during 2005. EN are concerned about the possibility of a "catastrophic event" (such as the lighting of a bonfire within the mine wiping out large numbers of bats). There is NO suggestion that cavers/mine explorers have participated in any antisocial behaviour that might threaten the bats. The gates are being installed to protect wildlife, not to stop interested parties from having access to this fascinating underground complex.


The CSCC is participating in consultations over the proposed future access policy and feedback from the wider caving/underground community is now being sought.

CSCC is strongly urging EN to allow unrestricted BUT CONTROLLED access throughout the year. A combination lock or multiple keys being available at, say, the Quarryman's Arms have been suggested, as has use of the CSCC standard padlock for which many clubs have a key. The CSCC also urged that having insurance should not be a pre-requisite for visitors to the site.
